SPOT ADMISSION FOR BA.LL.B (HONS.) & B.COM LL.B (HONS.) COURSES (SESSION 2026-2027)

- **Dates:** 30th July 2026 and 31st July 2026

Eligibility Criteria: Candidates must fulfill the minimum eligibility criteria in CAT Examination. As per Gauhati University Notification, the cut-off marks for admission to the 5 Year Integrated LLB programme (2026-2027 academic session) are revised to 60 for Unreserved (General/EWS) and 40 for the Reserved category (OBC, ST(P), ST(H), SC, PWD).

Instructions for Candidates:

1. Candidates must **compulsorily fill up the Google Form** before appearing for the spot admission.

2. Candidates must appear in person at the college campus during the specified dates and times.

4. Selected candidates must be prepared to pay the requisite admission fees immediately on the day of admission to secure their seats.

In continuation of the Standard Operating Procedure (SoP) issued with regard to CAT-2026, it is hereby notified for all concerned that the cut-off marks for admission to the 5 Year Integrated LLB programme (2026-2027 academic session), are **revised to 60 for Unreserved (General/EWS) and 40 for the Reserved category (OBC, ST(P), ST(H), SC, PWD).**

The above-mentioned revised cut-off marks shall apply prospectively and shall be applicable only to admissions to be granted during the final spot admission round, to be held on 30.07.2026 and 31.07.2026 to fill up the remaining vacant seats in the participating law colleges.

It is categorically clarified that the revised cut-off marks shall have no retrospective application and shall not, in any manner, affect, alter, or invalidate admissions already granted prior to the issuance of this notification.
